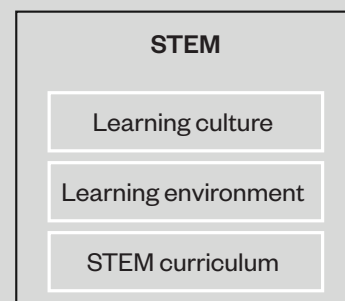
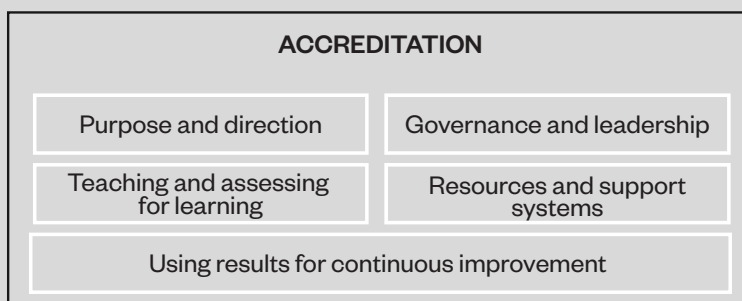

Setting a standard for STEM excellence

Cognia's STEM Certification is the first of its kind, providing recognition for early learning programs that demonstrate a strong and effective STEM focus.
